1. PROMOTION DESCRIPTION: The Climate Design Share the Cool AC Giveaway (“Sweepstakes”) begins on April 29, 2024 at 5:00 pm EST and ends on May 24, 2024 at 4:59 pm EST (the “Promotion Period”).

The sponsor of this Sweepstakes is Climate Design (“Sponsor”). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Sweepstakes.
